#### **CONTRACT NEGOTIATIONS 2012**

The URI PTFU Negotiation Committee has been meeting the past several weeks to prepare for contract negotiation sessions with representatives of the URI/BOG in working towards our 2<sup>nd</sup> collective bargaining agreement. The proposals to be placed on the table for URI PTF were prioritized by PTF members in a mail survey that was conducted by the Executive Committee and followed up by a full-day general meeting at which members further detailed and prioritized the requested contract improvements, including: access to health care benefits; PTF tuition waiver options; two-year time-frame appointments for PTF; salary increases for base salary, as well as increases for level advancement amounts, more in line with amounts paid PTF at other higher education public research institutions.

The members of the Negotiation Committee are: Edward Inman, Marilyn Donahue, Charles Chaves, Timothy Tierney, Dorothy Donnelly (Chief Negotiator), and Patricia Maguire (Executive Assistant, staff support). Other PTF members have volunteered to provide assistance on specific items of negotiation, as needed. We ask for your continued support during these challenging negotiations—we will keep you informed as the negotiations move forward.
