ACTIONS TAKEN (& UPCOMING) IN SUPPORT OF ARBITRATOR'S SALARY AWARD TO URI ADJUNCT FACULTY

TO: URI Adjunct Faculty & Other Interested Individuals

FROM: URI/Part-Time Faculty United Contract Negotiation Committee

We write to inform you of the status of our current contract negotiations. The URI/PTFU negotiation committee remains in negotiations with URI and the RI Council on PostSecondary Education (RI CPE) in our efforts to gain the salary increase awarded to URI PTFU by Arbitrator Hon. Frank J. Williams (Ret.) in his decision dated April 4, 2017. URI not only REFUSES to pay the Arbitrator's Award to the University's adjunct faculty but they also REFUSE to pay anything even close to what the Arbitrator awarded --and, obviously, what the adjunct faculty at URI are entitled to receive.

After participating in Interest Arbitration (lasting almost one year) and writing a court brief in support of their argument against a substantial salary correction increase URI LOST on this wage issue. URI's response to that *loss* is: 1)REFUSE TO PAY WHAT THE ARBITRATOR AWARDED, and 2) REFUSE TO PAY ANYTHING THAT IS EVEN CLOSE TO what the Arbitrator has awarded the URI adjunct faculty.

As part of the Interest Arbitration protocols the URI/PTFU Union was also required to submit a court brief to the Arbitrator. The Arbitrator concluded that the UNION, based upon the hearings, documents presented throughout the Arbitration process, as well as the Union's court brief, had made its case and WON on its proposed salary correction increase for the University's adjunct part-time faculty.

WE WILL CONTINUE TO FIGHT BACK AGAINST THE UNIVERSITY OF RHODE ISLAND'S STRONGLY NEGATIVE TREATMENT OF URI'S ADJUNCT FACULTY-PARTICULARLY ITS REPEATED DENIAL OF THE VALUE OF URI ADJUNCT FACULTY TO URI'S UNDERGRADUATE STUDENTS AS WELL AS THE UNIVERSITY'S ABILITY TO OFFER ITS UNDERGRADUATE PROGRAMS. (FYI: 29% of URI'S undergraduate program of study is offered by the University's adjunct faculty; 48% of URI's students are from out-of-state.)

We aim to present our case at numerous and various forums as long as it takes to achieve what the Arbitrator, after careful examination and analysis, concluded is a minimum salary URI's adjunct faculty deserve to earn.

Presented below is a summary list of actions taken and those to follow along with ongoing activities.
